If registration or transfer application for Sire or Dam accompanying this application does not comply with the information given, all applications will be returned.
- 2. To ensure proper registration of this litter, print CAPITAL LETTERS and stay within the lines. We are not responsible for misinterpretations. Errors may result in the cancellation of this application and will be required to present a new application with full payment.
- 3. SIGNATURES: wherever an owner's signature is required and dog is co-owned, only one signature is necessary. Signatures of persons other than owners or lessees will be accepted only if power of attorney or other official authorization has been filed with FCPR.
